Pig and Parrot Party Pontoon WAIVER

Pig and Parrot Party Pontoon is a US Coast Guard certified passenger vessel and undergoes rigorous training, inspections, and planning to ensure a safe environment for passengers and surround users of the Manasquan River and Barnegat Bay New Jersey. However, there are inherent risks associated with water activities. I understand that during my time and use of the Pig and Parrot Party Pontoon I may be exposed to a variety of hazards and risks, foreseen or unforeseen, which are inherent in being a boat passenger and participating in related water activities. These inherent risks include, but are not limited to, the dangers of serious personal injury, death and property damage resulting from, but not limited to: (i) physical exertion and activities, (ii) contact with other boats, marine wildlife, rip currents, and other water hazards, (iii) slipping, tripping or falling, (iv) falling from heights or off the boat, (v) inappropriate, intoxicated and unsafe behavior of passengers, (vi) sudden illness, (vii) malfunctioning equipment, (viii) inclement weather, and (viii) other hazards associated with travel on a boat and recreational water activities. I fully understand that the Pig and Parrot Party Pontoon or its staff has not tried to contradict or minimize my understanding of these risks. I know that injuries, damage and death can occur by natural causes or activities of other people, users, staff or third parties, either as a result of negligence or because of other reasons. I appreciate that I may have to use extra care to reduce the risks when exposed to these hazards. I understand that no medical facilities or expertise are readily available to assist with injuries or conditions. I acknowledge that the cruise may involve the consumption of alcohol by passengers and I accept those risks. I further acknowledge that it is my sole responsibility to consume alcohol in moderation and in a way that will not impair my safety or judgment. I take full responsibility for any liability associated with my intoxication, before, during or after the cruise.

In consideration for my acceptance as a passenger on the Pig and Parrot Party Pontoon, and the services and amenities provided, I CONFIRM MY UNDERSTANDING OF THE FOLLOWING:

RELEASE OF LIABILITY.

I understand and agree to WAIVE AND DISCHARGE CLAIMS AGAINST, RELEASE FROM LIABILITY, INDEMNIFY, DEFEND, AND HOLD HARMLESS the Pig and Parrot Party Pontoon and its owners, vessel, employees, affiliates, agents, or assigns from and against ANY AND ALL LIABILITY on account of, or in any way resulting from, my death, personal injury or damages related to my time and use of the Pig and Parrot Party Pontoon, even if caused by negligence. Such negligence could involve (a) negligent operation and supervision, (b) negligent maintenance or operation of the equipment or boat in general, (c) negligent manufacture or use of equipment to be used on the boat, (d) over-consumption of alcohol by passengers, and (e) the negligent facilitation or provision of emergency response services. I understand and intend this release to be as broad and inclusive as permitted by law, and to be binding upon my heirs, executors, administrators, and assigns. I am of lawful age and legally competent to sign this liability waiver.

I understand, that if I or anyone in my group, purposely jumps over board at any point while on the vessel, you are subject to a \$1,000.00 fine from Pig and Parrot Party Pontoon and furthermore from the US Coast Guard up to \$25,000. The authorities will be called and notified of the offense. We do this for the safety of our passengers and our staff. Swimming is only permitted in designated areas to be determined by the Captain. Swim at your own risk. IF YOU DO NOT KNOW HOW TO SWIM, YOU MUST NOTIFY THE CAPTAIN UPON ARRIVAL.

I understand, that this round trip cruise, everyone will board the vessel at the Brielle Yacht Club and return to the Brielle Yacht Club when cruise is complete. Only exception will be made for medical emergencies. We do this for the safety of our passengers and our staff.

I understand, that if I or anyone in my group, delays the vessel, you are subject to a \$1,000.00 fine from the Pig and Parrot Party Pontoon. We schedule several tours a day and need to stick to a schedule. Delaying the boat will interrupt tours for the entire day.

The following actions are prohibited on the Pig and Parrot Party Pontoon. The crew has the discretion to remove any passengers or cancel the cruise, if these rules are violated or any inappropriate behavior is escalated. No refund will be issued.

- Smoking
- Underage drinking
- Drug use/drug possession
- Weapon possession
- Over intoxication
- Vulgar language
- Indecent exposure
- Vomiting
- Public urination
- Littering
